Basic Facilities Charge per REU (BFC) <700 ft<sup>3</sup>

\$95.00 per quarter

Volumetric Rates – 700 cubic feet per quarter minimum

Metered Single Family Residential over 700 ft<sup>3</sup>

\$13.00/100 ft<sup>3</sup>/quarter

Metered Multi-Family – per REU over 700 ft<sup>3</sup>

\$13.00/100 ft<sup>3</sup>/quarter

Unmetered Single Family Residential

\$121.62/quarter

Unmetered Multi-Family – per REU

Seasonal Residential Rates Basic Charge per REU <1400 ft<sup>3</sup>

Volumetric Rates – 1400 cubic feet per season allowance

Metered Single Family Residential over 1400 ft<sup>3</sup>

\$13.00/100 ft<sup>3</sup>/season

Metered Multi-Family Residential over 1400 ft<sup>3</sup>

\$13.00/100 ft<sup>3</sup>/season

Unmetered Single Family Residential

\$243.24/season

Unmetered Multi-Family – per REU

Commercial Rates Year-Round Users (BFC)

Volumetric Rates– 700 cubic feet per quarter allowance or highest annual quarterly usage multiplied by \$0.0650 (50% of the residential rate per 100 ft<sup>3</sup>) whichever is higher.

\$13.00/100 ft<sup>3</sup>/quarter

Commercial Rates Seasonal Facilities (BFC)

Volumetric Rates - >1400 cubic feet per season

\$13.00/100 ft<sup>3</sup>/season

Minimum Bill per Quarter: \$0.0650 multiplied by the previous Year's highest quarterly usage in ft<sup>3</sup>

Off Season Charges When Closed for Business:

Minimum Bill/season (spring): \$0.0650 multiplied by the previous season's usage in ft<sup>3</sup>
