General Application for Waste Discharge License (WDL) / Maine Pollutant Discharge Elimination System (MEPDES) Permit

Regulatory requirements for the preparation and filing of applications may be found in Chapters 2, 521 and 522 of the Department's rules.

GENERAL INSTRUCTIONS

- This general form is to be used to make application for the discharge of pollutants to the surface waters of the State, from all source except from privately owned discharges subject to the Over Board Discharge Program requirements.
- 2. Applicants are responsible for publishing public notice of their application at the time it is filed with the Department. See pages 7 and 8.
- 3. For a proposed new discharge of wastewater of more than 25,000 gallons per day or a project involving licenses from more than two bureaus in DEP, an applicant must conduct a public informational meeting before submitting an application to the Department. See page 7.
- 4. In some circumstances an applicant must have a pre-application or pre-submission meeting with the Department prior to filing of an application. See page 9.
- 5. At the time an application is filed with the Department, a copy must be provided to the municipal office and notice provided to all abutters by certified mail. See page 7.
- 6. Application fees must be paid at the time an application for a new discharge or permit is filed. Contact the Department for additional information and calculation of the fee amount. For existing discharges, fees are charged on an annual basis and application fees are not required with an application for permit renewal.
- 7. Attach additional sheets as necessary in answering specific questions. Be sure to number each sheet to identify the question to which it pertains.
- 8. Failure to fully complete all required forms or to pay necessary application fees will result in the application being returned.

Instructions for providing notices of the application. For all applications, the first 3 items must be completed. If the application is for a new discharge, you must also complete item 4.

1. Publication of Public Notice. Applicants for waste discharge permits are required to publish a public notice that the application is being file with the Department of Environmental Protection. The notice must be published within 30 days prior to the application being sent to the Department. The notice should be published in the legal advertisement section of a daily or weekly newspaper having general circulation in the area where the discharge will occur. If the public notice is not published at the proper time or if the application is returned because it is incomplete, you may be asked to have the notice published a second time.

Using the form on the next page, fill in the blanks with the appropriate information. Strike out all of the items (CSO, multiple discharge sources, etc.) in the second paragraph that do not apply to your discharge. The form may then be sent to the newspaper that is to publish the notice. Additionally, include a copy of the form with the application filed with the Department.

- 2. Notice to Abutters. Applicants are also required to send a copy of the public notice by certified mail or Certificate of Mailing to all abutting property owners within 30 days prior to the application being filed with the Department. For the purposes of public notice of this application, an "abutter" is any person who owns property that is both (1) adjoining and (2) within 1 mile of the delineated project boundary, including owners of property directly across a public or private right of way. Additionally, include a copy of the form with the application filed with the Department.
- 3. Notice to Municipal Office. Applicants are required to send a copy of the public notice by certified mail to the town or city clerk of each municipality where the discharge is located within 30 days prior to the application being filed with the Department. Applicants must also file a duplicate copy of the application with each municipality.
- 4. Public Meeting. Where the application is for a new discharge of greater than 25,000 gallons per day, you must hold a public meeting in accordance with Chapter 2, Section 8, of the Department's rules. Notice of the meeting must be sent to abutters and the clerk of the municipality(ies) where the discharge is located at least 10 days prior to the meeting. Notice of the meeting must be published in the same newspaper used to publish the notice of filing.

Pre-application and pre-submission meetings

Pre-application meetings. Pre-application meetings between the applicant and the Department are an opportunity for the applicant to determine the statutory and regulatory requirements that apply to a specific project and to identify a Project Manager for the application. The purpose of these meetings is to identify issues, processing times, fees and the types of information and documentation necessary for the Department to properly assess the project. The applicant shall consult the appropriate bureau Permit Assistance Coordinator to determine what information the applicant must provide before or during a pre-application meeting. Any applicant may request a pre-application meeting. The Department shall make a date available for the meeting as expeditiously as possible, but no later than 30 days from receipt of a written request and receipt of all information required for a pre-application meeting by the bureau. The Department shall prepare a written summary of all pre-application meetings.

For waste discharge permits, pre-application meetings are <u>required</u> prior to submission to or acceptance by the Department of an application for the following:

New wastewater discharge license for a discharge greater than 25,000 gallons per day (38 M.R.S.A. Sections 413, et seq.);

Projects requiring new or amended licenses involving more than two bureaus.

Pre-submission meetings. Pre-submission meetings between the applicant and the Department occur after the applicant has finished preparing the application for submission. These meetings are an opportunity to review the assembled application to ensure that the necessary information has been included prior to filing the application with the Department. An applicant may request a pre-submission meeting by contacting the Project Manager, or the Permit Assistance Coordinator for the bureau if no Project Manager has been identified. The Department shall make a date available for the meeting as expeditiously as possible, but no later than 20 days from receipt of a written request.

For waste discharge permits, a pre-submission meeting is <u>required</u> prior to submission to or acceptance by the Department of an application for the following:

Any application for which a pre-application meeting was held; or

Any application that has been previously rejected by the Department (see Chapter 2, Section 7-B of the Department's rules).

Waivers. The requirement of a pre-application or pre-submission meeting may be waived by written notice from the Department and agreement by the applicant. The Department will agree to waive a pre-application or pre-submission meeting if the Department is satisfied that such a meeting would be of no value in achieving the purposes noted above.

Note: The waiver of a pre-application or pre-submission meeting does not waive the public informational meeting required for new discharges of more than 25,000 gallons per day.

ATTACHMENT A

Description of Emergency Discharge Points (EDP's)

There are six known EDP's in the Boothbay Harbor Sewer District sewer system. The EDP locations are also shown on Attachment I.

EDP #002

EDP #002 is located just west of the wet well of Pump Station #1 (Head of the Harbor) on Union Street between Pear Street and Gilead Streets. The EDP consists of an 8-inch pipe cut into the wet well at an elevation 2.5 feet above the high water SCADA alarm point, extending south across Union Street and into the waters of Boothbay Harbor. The EDP was constructed during the time of installation of the wet well, 1963.

EDP #003

EDP #003 is located approximately 300 feet northwest of Pump Station #3 (Mill Cove) on the south side of Western Avenue (State Route 27) where Mill Creek enters Boothbay Harbor. The 8-inch EDP pipe is visible above the creek, and is connected to a manhole located just to the west of the creek off the roadway. A high water alarm point is programmed into SCADA. According to District record drawings of the system, the manhole was existing at the time of construction of the pump station and surrounding sewers. The EDP may have been the original discharge point prior to construction of the pump station and treatment plant.

EDP #004

EDP #004 is located in the wet well of Pump Station #2 on Atlantic Avenue across from Atlantic Edge Lobster. The EDP consists of a six-inch pipe going from the pump station wet well and travels west across Atlantic Avenue and terminates under the Harbor Master office building. The invert of the EDP is 5 feet above the high water alarm SCADA set point. The end of the EDP pipe has a tide-check valve installed to prevent intrusion.

EDP #005

EDP #005 is located in the first manhole to the north of Pump Station #5 (The Meadow) on Townsend Avenue (State Route 27). The 8-inch EDP pipe is about 5 feet above the manhole invert, and discharges to Mill Creek on the western side of the bridge over the creek. The EDP is protected with a tide-check valve and has a high water alarm programmed into SCADA.

EDP #006

EDP #006 is located in a manhole (MH 2-53) just off the end of Giles Place on a 10-inch gravity interceptor line. The EDP manhole is between the terminus of the force main from Pump Station #3 and the 14-inch pressurized treatment plant influent sewer line located on Sea Street. It appears that the EDP was constructed to protect surrounding homes from damage during those times when heavy rains occur. A high water alarm float switch is installed and connected to SCADA. The alarm is set for 3 inches below the invert of the EDP pipe.

EDP #007

EDP #007 is located in the wet well of Pump Station #18 located on McKown Point Road at the Department of Marine Resources. The 8-inch EDP pipe is 6 feet above the high water alarm point for the pump station. The EDP was constructed by the State of Maine as part of the Department of Marine Resources new aquarium and laboratory facilities. The District acquired the pump station and gravity sewers as a result of negotiations with DMR and the Juniper Point Effluent Control Corporation (JPECC). This EDP is protected by a tide-check valve and a High Water alarm is programmed into SCADA.

All six of the EDP points were apparently constructed to protect the areas around the pump stations and treatment plant from damage in the event of an extended power failure, pump station failure, or excessively high flows. The Boothbay Harbor Sewer District sewer system is a separate sanitary sewer system, although excessive inflow is known to enter the system and result in high flows.



ATTACHMENT B

Boothbay Harbor Sewer District Operations Description

The Boothbay Harbor Sewer District provides secondary treatment to wastewater generated in Boothbay Harbor, Boothbay, Squirrel Island, and Capital Island. The District also receives wastewater and process wastewater from the Boothbay Region Water District Water Filtration Plant.

Wastewater enters the District's treatment plant located on Sea Street in Boothbay Harbor. The District utilizes preliminary treatment, secondary treatment, disinfection, and dechlorination prior to discharge into Boothbay Harbor.

As wastewater enters the plant, the flow goes through preliminary treatment. This process consists of the removal of screenings through a mechanical bar rack. Grit is then removed through a grit chamber, washed, and grit is then removed though a screw conveyor, and is stored for removal with dewatered biosolids to the Hawk Ridge Compost Facility or Juniper Ridge Landfill for processing. After this process, the wastewater then enters the wetwell for storage.

The wastewater now enters secondary treatment. The District utilizes sequencing batch reactors (SBR's) for treatment. This process combines primary and secondary treatment into a single process. As wastewater enters the SBR's, the SBR fills according to the operational phase it is in. Once the fill cycle ends, flow enters the other SBR and starts the treatment cycle again.

After the wastewater has been treated, the wastewater is allowed to settle. This allows for the separation of activated sludge from the wastewater. After settling, the effluent is discharged to the chlorine contact tank where sodium hypochlorite is added for disinfection. After 30 minutes of contact time, water is then dechlorinated with sodium bisulfite. This reaction is immediate. Any scum or floatable solids are removed, by skimmers, to the aerated sludge holding tank. Wastewater is then discharged to Boothbay Harbor. At the end of the decant cycle, activated sludge is wasted to the aerated sludge holding tank and thickened for later treatment.

Waste sludge that is removed from the process, during secondary treatment, is stored in the aerated sludge holding tank. The sludge is thickened to 1 to 2 percent.



ATTACHMENT B

The sludge is dewatered with an Andritz centrifuge. Sludge cake out of the centrifuge averages 19 to 22 percent solids.

The District utilizes two options for sludge utilization. First option is composting and the second is disposal at the Juniper Ridge Landfill in Old Town. The first option for sludge disposal is composting at the Hawk Ridge Composting Facility located in Unity, Maine. At present, the District contracts biosolids disposal to Casella Organics of Unity, Maine. This option is the method of choice at this time. The second option is for the dewatered solids to go to Juniper Ridge Landfill in Old Town. Casella Operates this landfill. Casella decides where the dewatered solids are disposed of.

The application is for the discharge of 640,000 gallons per day of secondary treated wastewater from the Towns of Boothbay, Boothbay Harbor, Squirrel Island, and Capital Island (both of Southport) to (Boothbay Harbor/Atlantic Ocean) in Boothbay Harbor, Maine.

The Application will be filed on or about July 27, 2020, and will be available for public inspection at DEP's Augusta office during normal business hours. A copy may also be seen at the municipal office in Boothbay Harbor and at the District's Sea Street office during normal business hours.

A request for a public hearing or request that the Board of Environmental Protection assume jurisdiction over this application must be received by the DEP, in writing, no later than 20 days after the application is found acceptable for processing, or 30 days from the date of this notice, whichever is longer. Requests shall state the nature of the issue(s) to be raised. Unless otherwise provided by law, a hearing is discretionary and may be held if the Commissioner or the Board finds significant public interest or there is conflicting technical information.

ATTACHMENT E

The following modifications and or upgrades have occurred in the collection system and at the treatment facility since the last permit application:

Collection System

1) Union Street Pump Station Upgrade:

The 1963 vintage pump station (dry pit/wet well) and 8-inch cast iron force main were replaced with a new larger 8-foot diameter submersible pump station and 8-inch HDPE force main. The station capacity was increased from 3 pumps @ 300 gpm (650 gpm total) to 2 pumps @ 450 gpm (900 gpm total). New controls and telemetry were part of the upgrade. In addition, a 10-inch sewer was rerouted directly to the new wet well. This prevented surcharging in the old 8-inch sewer. The old wet well was converted to a grit trap and remained in use. The station went online in 2018.

2) Relining of Asbestos Cement Sewer Line:

17,000 feet of asbestos cement sewer interceptor was relined along with all service connections grouted. The sewer lines were located along Atlantic Avenue, Lobster Cove Road, Bay Street, Union Street, Kenny Field Drive, Park Street, Commercial Street, and Sea Street. The project was completed in 2017

3) Massachusetts Road Pump Station Upgrade:

This pump station is a small residential station rated at 45 gpm. The station had new pumps, discharge piping, removal rails, electrical, control panels, and telemetry installed. This was done in 2019.

4) Juniper Point Pump Station:

This pump station is a small residential station rated at 45 gpm. The station had new pumps, discharge piping, removal rails, electrical, control panels, and telemetry installed. This was done in 2018.

5) Emery Lane Pump Station:

This station was installed in 2001. It is a dedicated station for the St. Andrews Village Retirement Facility. The station has been plagued with plugging issues from the facility. The existing Flygt cutter pumps were replaced with Vaughn Chopper pumps. New electrical (single phase to 3 phase), controls, and telemetry were also installed. This was completed in 2020.



6) Route 96 Sewer Replacement:

The District replaced 1,800 feet of old 6-inch, deteriorated, asbestos cement pipe with new 8-inch PVC pipe with an extension of an additional 1,000 feet of 8-inch sewer to the intersection of Eastern Avenue. Additional services and cross laterals were installed at Montgomery Road for future use. The number of manholes installed increased from 3 to 11 for ease of line maintenance. The project was completed in the spring of 2020.

Wastewater Treatment Facilities

1) Grit Removal System:

The original Jetta grit pump and Jones and Howard Grit system was replaced with a new Smith and Loveless grit pump/controls and a new Wes-Tech grit washer/classifier/control. The unit was placed online in 2016.

2) New Influent Pumps:

The District replaced the three Wemco influent pumps with new Wemco influent pumps. The old pumps were obsolete, and parts were scarce. In addition, the pump wear rings were not adjustable. The new pumps are adjustable. The project was completed in 2020.

3) New Influent, Decant, and Aeration Actuators and Valves Replaced:

The district replaced the original (1994) plug valves on the aeration, influent, and decant lines with new Milliken plug valves. In addition, the district replaced the Limitorque actuators on each of the valves with new actuators.

4) Aeration Grids/Superstructures Replaced:

Both SBR tanks were taken down and inspected. During the inspection, each aeration grid was serviced (150 tubes replaced) in each SBR. In addition, all of the galvanized steel superstructure was replaced in each SBR. This was a total rebuild of both SBR's. The project was completed in early 2020.

5) Disinfection System Replaced:

The disinfection system was total rebuilt in 2016. New 1,000-gallon storage tanks (2) were installed along with the associated piping. New Masterflex peristaltic pumps and controls were installed. New ATI Total Residual Chlorine Analyzers replaced the old ones along with Moore controllers to flow pace the sodium hypochlorite addition. New Stenner peristaltic pumps were installed on the sodium bisulfite system.



6) SBR Controls:

The original (1994) control system was totally replaced and upgraded with new programming controls hardware. The old system was very "buggy" and caused some process upsets. The new upgrade has provided fixes to those bugs and has allowed the district to control the process via dissolved oxygen. This has saved the district electrical costs as well as provided much tighter process control. The project was completed in 2016.

7) New Polymer System Installed:

A new polymer feed system was installed for the sludge feed to the centrifuge. The old PolyBlend system was a maintenance nightmare and resulted in constant overfeeding of polymer. The new system allows for better feed control through flow pacing and the peristaltic pump. The new system went online in the fall of 2018.

8) New Odor Scrubber Installed on Centrifuge:

The district installed a custom odor scrubber on the centrifuge vent line and discharge chute. The unit was fabricated by MI Air in Georgia. The unit has resolved fugitive odor emissions from the vent line. The system was placed online in early 2020.

9) New Plant Lighting Installed:

The district replaced all of the plant and office lighting with new LED fixtures. The lighting was partially paid for through an Efficiency Maine grant. The upgrade was done in 2018.





SEPTAGE RECEIVING TANK PLAN VIEW 1 REQUIRED 2








BOOTHBAY HARBOR SEWER DISTRICT SEPTAGE PROCESSING FLOW DIAGRAM

ATTACHMENT K

The Boothbay Harbor Sewer District collection system is 57 years old and newer. However, there are private service mains that are older and connect to the District's sewer system. Most of the older service mains were intercepted when the sewer system was constructed in 1963. Because the older services were constructed before the days of current sewer rules and regulations, some foundation drains and area drains may be connected. During significant or extend rain events, (>1.5") inflow of clean water can be an issue. During this period and periods of high groundwater, I & I can lead to diluted influent wastewater and may cause an issue with percent removal calculations.

The District recently relined and grouted all the services connections on Atlantic Avenue, Bay Street, Commercial Street, Commercial Street Extension, Kenny Field Drive, Lobster Cove Road, Park Street, Sea Street, and Union Street.

The District is in the process of identifying other areas of I & I through smoke testing, and video inspection investigations. The District is still working on sump pump removal on private property.

The District currently accepts domestic septage only. No industrial waste is accepted. Grease trap waste is not accepted. Preference is given to residents of the District (Boothbay and Boothbay Harbor). Septage is brought to the District via private haulers. Prior to dumping, the hauler informs the operator, identifies the source and type of waste that is being hauled. The District operator records the initial magnetic flow meter totalizer reading and unlocks the fill valve. During dumping the operator will sample the septage for COD, pH, and TSS on an as needed basis. After dumping, the operator obtains the final totalizer meter reading, fills out the manifest with the delivered amount, date and time of delivery, and the facility information. The operator signs the manifest and retains a copy. The operator logs the information onto the septage addition/receiving log and the DEP 49 Form.

The District offers a 5,000-gallon aerated holding tank for use. The tank is screened with a 1-inch manual bar rack. The rack is cleaned after each dump. All screenings are collected, treated with hydrated lime, and disposed of in doubled plastic bags and disposed of at the Boothbay Region Refuse District transfer station.

The District holds septage in the holding tank and allows the septage to aerate. Sodium Hypochlorite is added to eliminate odors and kill filamentous bacteria prior to addition. After this process, the septage is metered into the influent wastewater via the plant headworks. The operator sets a timer that controls the septage pump. Septage is introduced into the plant at night during low flow periods at a rate of 400 gallons per 2-hour period until the tank is empty.

Below is Section 14 of the District's Rules and Regulations regarding septage disposal.

SECTION 14 - SEPTAGE DISPOSAL

No person shall discharge hauled septage at the District's wastewater POTW who does not hold a septage hauler permit issued pursuant to MEDEP Rules 06-096, Chapter 411 Non-hazardous Waste Transporter Licenses, as amended.

A copy of such permit shall be filed by the permit holder with the District. Upon renewal or revocation of such permit, the hauler shall be responsible for notification of such renewal or revocation to the District. Any permit issued in accordance with these Regulations will be subject to revocation by the District on the basis of failure to pay proper charges, use of other authorized disposal sites, failure to meet sanitary standards, discharging or industrial sludge or other unacceptable waste into the system or for any other infraction of these Regulations.

14.1 Septage Hauler Requirements

- A. A permitted hauler may discharge septage to the facilities provided at the District's wastewater treatment facility only after paying the charges as set forth in Section 14.4 of these Rules and Regulations.
- B. Those persons, firms, corporations, municipal subdivision, or institutions that conform to state definition of "RVs" shall dispose of such septage as human excrement or other putrescible materials at the dates, times, and locations designated by the Superintendent.
- C. No person, firm, corporation, municipal subdivision, or institution shall discharge any toxic, poisonous, radioactive solids, liquids or gases, or the contents of grease, gas, oil and/or sand interceptors into the District's wastewater treatment facility.

14.2 Temporary Septage Permits

The Trustees may issue a temporary permit to allow the discharge of septage at a point of discharge other than the wastewater treatment facility in a situation where such temporary discharge point is necessary to protect the health and welfare. The Trustees shall issue such permit upon such terms and conditions as the Trustees deem to be in the best interests of the District. The temporary permit shall not be valid for a period exceeding twelve (12) months. The District shall have the right to revoke or suspend the temporary permit in the event that the terms and conditions are not met.

14.3 Septage Permits

A. Any septage hauler who intends to dispose of septage at the District shall first obtain a permit from the District.



- Such permit as issued by the District shall identify: B.
 - The motor vehicle. 1.
 - The capacity of the tank. 2.
 - The ME DEP Registration Number/US DOT Number 3.
 - The MEDEP Permit Number; and 4.
 - Any other details of compliance with MEDEP rules. 5.
- The following conditions shall constitute conditions precedent to the C. issuance of each permit by the District:
 - Each septic tank truck shall be equipped with either a sight level by 1. which the quantity of the contents of each tank may be ascertained by sight or an access port through which the quantity of the contents of each truck may be ascertained by depth measurements. Every tank truck whose contents shall be discharged into the treatment system shall be equipped with a discharge system that will insure the clean and complete discharge of such contents into the designated area provided by the District.
 - Because the septage handling capacity of the plant is limited, all 2. haulers must schedule discharges at least one day, but no more than three days, in advance. Deliveries can be scheduled by calling the wastewater plant. Failure to schedule in advance may cause refusal to discharge.
 - Prior to discharging the load, the hauler shall report to the operator 3. and the operator will record the following information in a log at the POTW:
 - The hauler's name. a.
 - Date. b.
 - Time of disposal. c.
 - Volume disposed. d.
 - Origin of load (property owner's name, address, and telephone e. number); and
 - Nature of the waste being disposed. f.
 - The Driver will sign the manifest record certifying the g. information is correct and the waste contains no suspected toxic materials.

- 4. Such log as described in Section 14.3(C) (2) shall be located in the treatment plant office and shall be accessible to the Superintendent.
- 5. Owners of "RVs" who intend to discharger the contents of holding tanks are exempt from the permitting process.
- 6. The District maintains the right to sample the contents or measure the amount of any load prior to discharge to the plant; also, the District reserves the right to confirm by telephone the source of the load. If there is a question as to whether a load is septage or holding tank waste, the following test will determine the results. A sample will be taken and allowed to settle for one-half hour. If the sample contains 200ml or more of solids per liter of sample, the load will be considered to be septage.

14.4 Septage Disposal Charge

There shall be a Septage Disposal Charge as established by the Trustees and amended from time to time for the receipt of septage into the District's POTW for treatment. All septage shall pass through a 3-inch magnetic flow meter and the totalized gallonage billed at the current disposal rate.
