Call to Order

Waiver of Entrance Fee for 28 Montgomery Road - Kitty Hartford

Ms. Hartford has requested a waiver of the entrance fee for 28 Montgomery Road in Boothbay Harbor. Ms. Hartford has been paying Ready-To-Serve since 2006 when she bought the property. Chris advised that the property does not abut the public way, but has easement rights to the public sewer. By Charter definition, property must abut the public way unless a pipe is installed across property to the public sewer. After discussion, Ted Tedeschi made motion pursuant to the charter definition and because the entry fee was paid as a ready-to-serve fee, to waive the entry fee for this property. Jim Stormont seconded the motion. Chris will advise Ms. Hartford of the decision.
