**REVIEW WARRANT #1009:**

### SUSAN FARRIN LETTER:

Ms. Farrin has requested that her property 37, Summit Road, be billed at the metered rate minimum instead of the flat rate for well customers. The reason for the request is that Ms. Farrin does not have room to install a meter on her well as well as, being the only person living in the trailer. The trailer is cramped for space and District employees have verified the space constraints. In addition, Ms. Farrin has also requested that should the Trustees grant her first request that she be issued a credit for the difference in the billing rate retroactive to January 1, 2001, the implementation of the metered method of billing.

After discussion, Robert Muller made a motion to reduce Ms. Farrin's billing rate to the current minimum for metered customers and to issue her a credit of \$549.90 plus a credit for the meter, \$45.00. David Gaecklein seconded the motion. Vote to allow the motion was unanimous.

ELECTRIC RATES - MAINE POWER OPTIONS:

A letter, dated March 2, 2004, was reviewed. The letter indicated that large power users would see a rate increase in the power bill. See Maine Power Options file for the letter. No action was taken.
