Old Business:

- 1. Union Street Pump Station Project The superintendent reported a walk through is scheduled for April 24 with Sargent and Wright-Pierce. The final punch list will be developed, and paving will be discussed. The contract requires Sargent to be complete by May 18, 2018. There was nothing else to report.
- 2. Plant and Collection System Operations: The superintendent reported normal plant operations since the last meeting. The CSO is still out of work. The advertisement for Seasonal Help has been unsuccessful with no applications received.

The superintendent reported the collection system crew continues to maintain the screens at St. Andrews Village. The superintendent reported meetings with St. Andrews Village management regarding the station upgrade are ongoing. A trip to York Beach is scheduled to view their Vaughn Chopper Pumps on April 27.

AC Electric has three other pumps since the last meeting. DMR pump 2 is there as the seal failed and oil entered the stator. PS 6 pump 1 is there being evaluated. Pump 2 from Chapel Street Station had a failed seal and oil entered the stator of that pump. We are awaiting evaluation on all of them.

All other work was routine.

- 4. Plant Influent Hydraulic Study Nothing to Report.
- 5. Website The Office Manager reports DD Customers @ 184, email billing @ 224, savings \$170.15 YTD, 35 new and 9 returning visitors to the website and 650 hits on the Facebook page since last meeting.
- 6. Golf Course Phase 2 The superintendent reported communication with Knickerbocker Group regarding the entry permit and fee. The fee had to be recalculated due to modification of the original plan. Both should be here by April 30, 2018.
- 7. 2017 Audit The superintendent reported we are waiting for completion. No word when that will be.
- 8. Roundabout Project Update: Nothing new to report.

- 9. Bowker Report The superintendent reported the Odor Evaluation Report was sent to the Signal Point Homeowners Association. The superintendent advised the first look at the potential rate impact was in the 10% to 12% range. More finite expense projections will be forthcoming.

- 11. Robert Scanlon 6 Atlantic Avenue Sewer Abatement Request The superintendent reported no word back from Scanlon on this issue.
