CARLO PILGRIM/TIM BROWN-PUMP OUT: Carlos Pilgrim here to describe system of pump out boat to service Harbor boats. Pam Parker from DEP described Clean Boat Program/Grant. Clean vessel Grant, 50-15- pump outs with a projected increase of 25% annually. Town's program will be monitored and operated through Public Works Department. The program will be Wednesday through Sunday. Friends of Casco Bay, Town of Falmouth, Camden and Mount Desert Island. Friends of Casco Bay have been operating for seven years. In final analysis, Town will work with District to monitor program. Jody Lewis will get with Chris Higgins to discuss program implementation at Fish Pier.
