Bureau of Labor Standards Inspection:

Chris advised that the District was cited for several violations and was assessed a proposed fine of \$4,950.00. Most of the fines were associated with wrong training that was conducted. Chris is going to remediate the citations and ask the BLS to reconsider the fines. The District has until November 15, 2010, to correct the issues.
