Call to Order:

Jim Stormont called the meeting to order at 18:03 hrs.

Review of the Minutes of August 18, 2010

The minutes of August 18, 2010 regular meeting were reviewed. After review, Jon Draper made motion to accept the minutes of August 18, 2010. Michael Feldmann seconded the motion. Vote to accept the minutes was unanimous.

Review of Warrant(s) 1169

Doane Hessleton Abatement Request:

Chris advised that the District abate the bill to an off-season average because of pool filling through his meter. This would be a one-time request and that the Association would have to install a meter to compensate for future usage. The trustees agreed.

Union Court Project:

Chris presented the Board with the estimate for doing the work. The estimate is \$31,066.14. Chris explained the layout and refreshed the information for the Board. Chris explained the process of construction and timing. Jim asked about financing. Jim was concerned about funding options. Chris responded that this project would have to come from contingency. Jon Draper made motion to install the line along with the Water Company and town. Michael Feldmann seconded the motion. Vote was unanimous.

Chris generated a letter to send to the park. The Board agreed to forward the letter to the park for their response. Jody also asked if the District did jobbing. Chris asked the Board if the District would be interested in perform job work. Jim advised that the District should not be in the contracting business. The other trustees agreed. Michael Feldmann made motion not to perform contracting work. Jon Draper seconded the motion. Vote was unanimous.
