## Financial Reports as of 11/30/13:

Chris handed out the year-to-date as of 11/30/13 financial reports and balance sheets. The trustee's reviewed the reports. No other action taken.

## 3<sup>rd</sup> Draft 2014 Budget and 2014 Sewer Rate Workshop:

Chris distributed the third draft of the 2014 budget. Chris explained the sheets have been updated with year-to-date revenue and expenses. Chris advised the salary page (page 6) items were updated. The trustees reviewed the line items for changes and adjustments. The Overtime line was discussed. The Entrance Fee line was discussed.

Chris explained the impact of assessing a fee for the upgrade of PS 9. Chris will presented the analysis of impact to each user for the PS 9 project amount. The Water District will fund the 90% of the upgrade due to their excessive flow proportional share. Other users along the reach will range from \$5.16 to \$94.27. After discussion, Deryl Kipp made motion to move forward with the assessment. Ted Tedeschi seconded the motion. Vote to proceed was unanimous. Chris will move forward with the notification procedure and public hearing.

Chris presented and explained the rate analysis breakdown for 2014. Chris advised that the notification of public hearing was sent to all users and the notification will be published in the Boothbay Register during the 12/4 and 12/12 editions.

#### 2014 Pick-Up Truck Purchase:

Chris advised that we received proposals from Newcastle 20,995, Wiscasset Ford 19,927, O'Conner 25,071, Quirk (2) 24,078, 21,204, and Shepard (2) 26,963, 29,753. Chris advised that 4 dealers did not submit.

The trustees discussed the two low bids (Wiscasset Ford and Newcastle). The differences were in warranty and engine size. After discussion, Deryl Kipp made motion to accept the proposal from Wiscasset Ford for 19,927. Ted Tedeschi seconded the motion. Vote was unanimous.
