Safford passed estimate sheet to group showing cost estimates of projects needing attention this year.C.S.O., I & I, FAT problems explained.

Trustees expressed desire to consider the line on Atlantic Avenue to the gates of Spruce Point, but feel that at the present it might be a tough time to get a favorable vote from the Town because the takers would receive another rate increase on top of the one just levied.

Trustees suggested people appoint committee to see if proposed takers would put up money themselves to lower cost to Town-which might help to get a favorable vote, as has been done in past.

Extensions have been put in by District alone, by takers alone, and with participation of both District & takers.

Trustees received negative comments from some people-they feeling District shold pay all.

Also requested people provide information as to number of proposed takers or homes in area, how many would be willing to tie in etc. This was also directed back to the District by negatine replies.

The estimated cost by W & P to do this prelimenary survey=\$1,500./\$2,000.

After much discussion people agreed to have Hallinan and Slayton, as contact people for Atlantic Avenue residence to work with the District.

The point was raised that it would be alot cheaper to install now along with the Inn's installation. Trustees agree but the time element of construction makes it impossible. Explained the route that has to be taken to build an extension:-engineering survey, costs developed, town vote to authorize, advertise for constuction bib, etc.

Other options suggested:-lay another force main in trench to serve low area from pump station. Also install gravity section only along with Inn's line. Felt that force main would not serve enough and that gravity line would slow Inn's already extremly tight time schedule.

Trustees feel only possible way is to install, if system is voted in, next fall or when Inn line in not in use.

Estimated cost of project is \$300,000. at estimated yearly cost to District of \$40,000.

If problem had been presented early enough to go in with the Inn's construction the estimated extension cost is \$200,000. to \$250,000.
