Representatives of the Boothbay Harbor Sewer District met with the town's board of selectmen Monday evening to once again request that street lighting be placed within close proximity to the Sewer District building, located on Sea Street.

Sewer district trustee John Arsenault attempted to justify the request by stating that it is sometimes necessary to get into the building under emergency conditions and that with little illumination it would be difficult to unlock the gate to enter the grounds. At an earlier meeting the board opposed the request on the basis of the Sewer District being a private entity which functions independent of town funding. Board members did agree, however, to review the situation once again and see if the possibility exists for relocating a light already in use on the street.

Town manager Malcolm Hunter informed the board that Maine Yankee has been notified in regards to the townspeople's vote to have their siren located on Mr. Pisgah removed. According to Hunter, Yankee's legal department is currently checking out the procedure and the possibility of a necessary revision to the evacuation plan.

Board members also approved opening the town's restrooms for the season on weekends only, for the present. with Fishermen's Festival coming up and the increase in tourists in town over the weekends.

In other business, the board approved renewal liquor licenses for Country Greens and Fishermen's Wharf: a renewal victualer's license to Country Greens; and a special amusement class C license to Fishermen's Wharf. The board tabled a request for a new class G victualer's license for Burger King pending inspection of the facility.

The board also gave their approval for the Merchants' Division of the Boothbay Harbor Region Chamber of Commerce to hold their annual spring sidewalk sale on Saturday. May 19.
